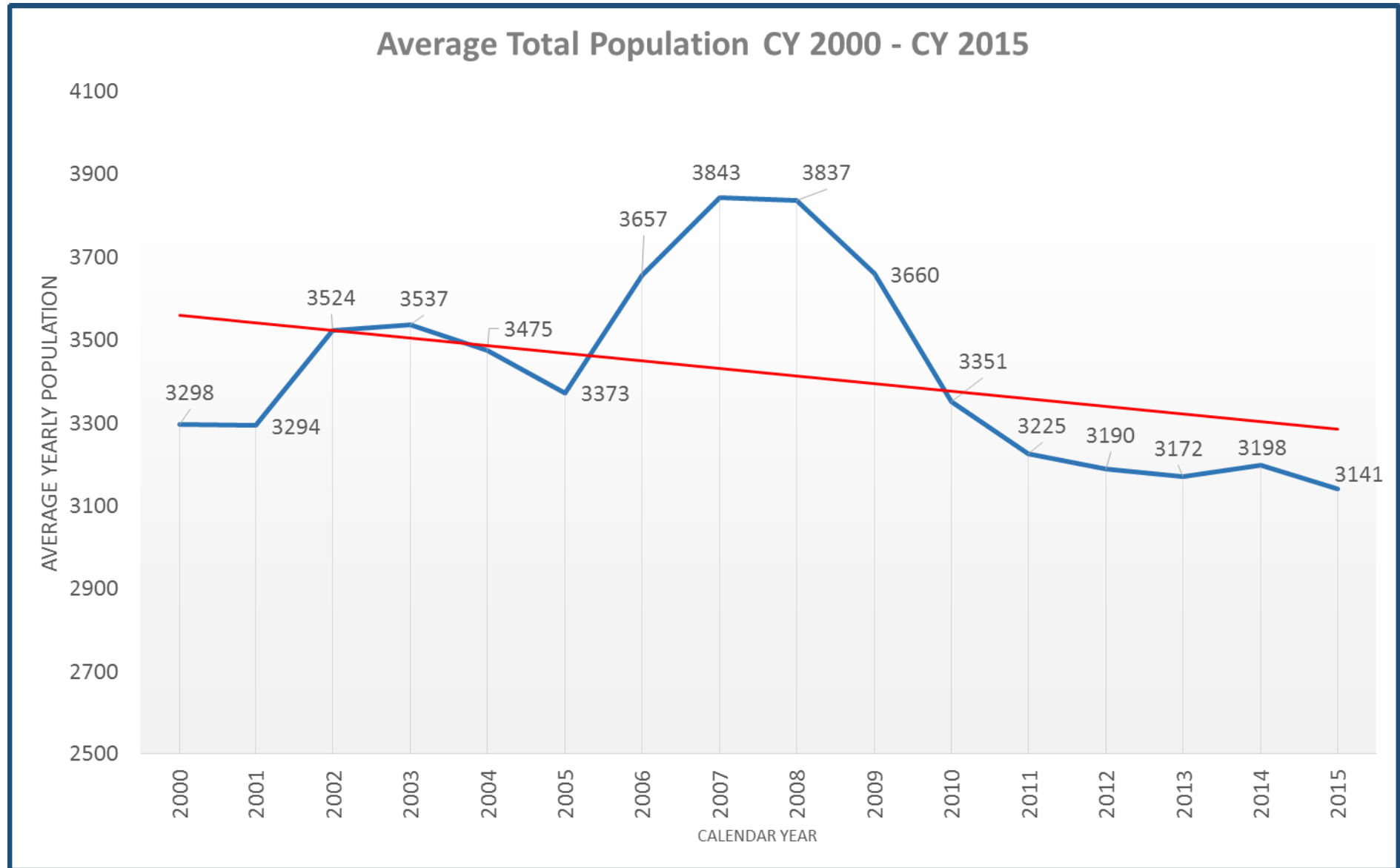

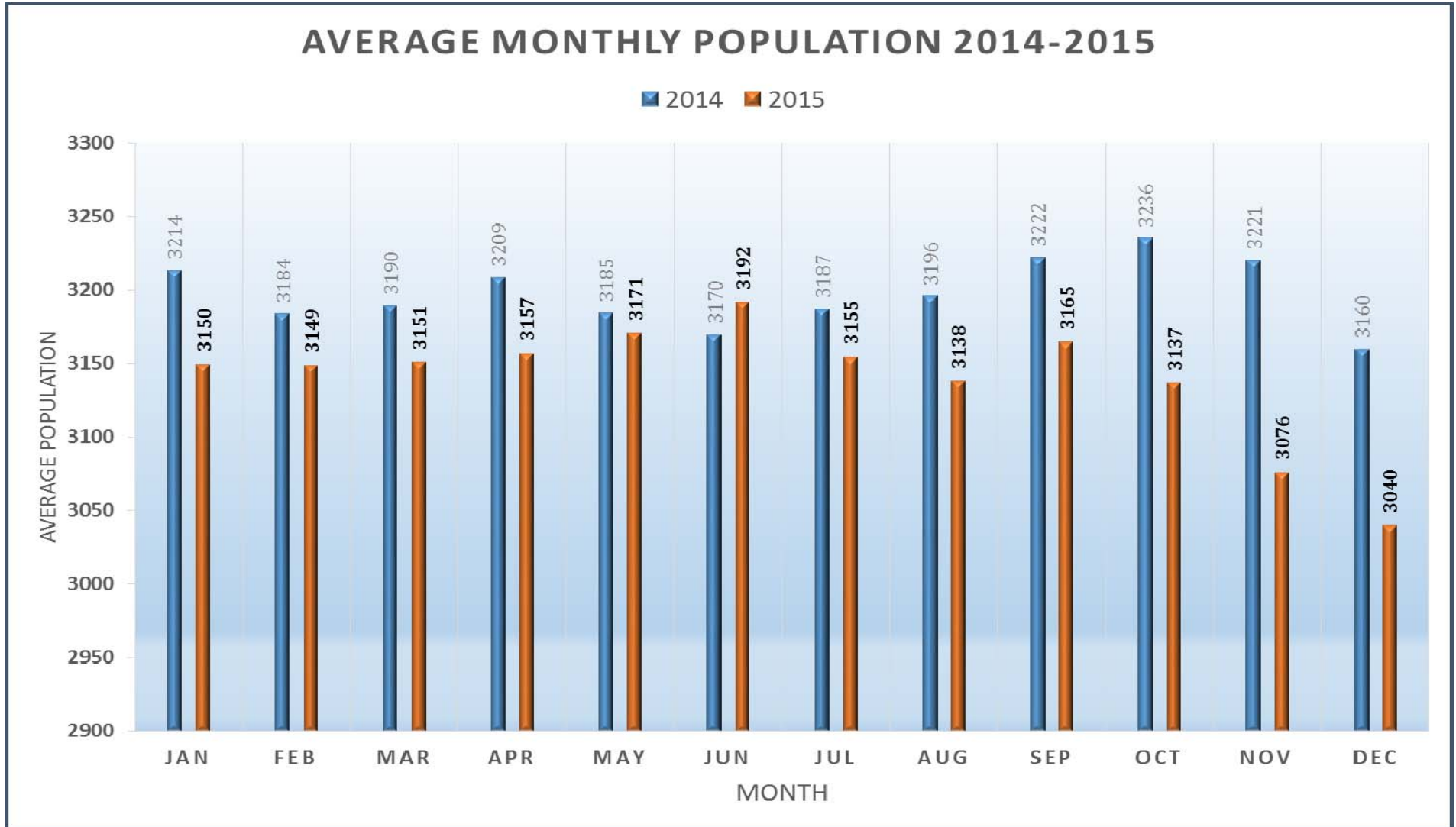
Average Total Population CY 2000 to CY 2015

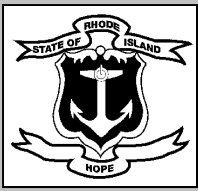




Average Total Population by Month Calendar Years 2014-2015

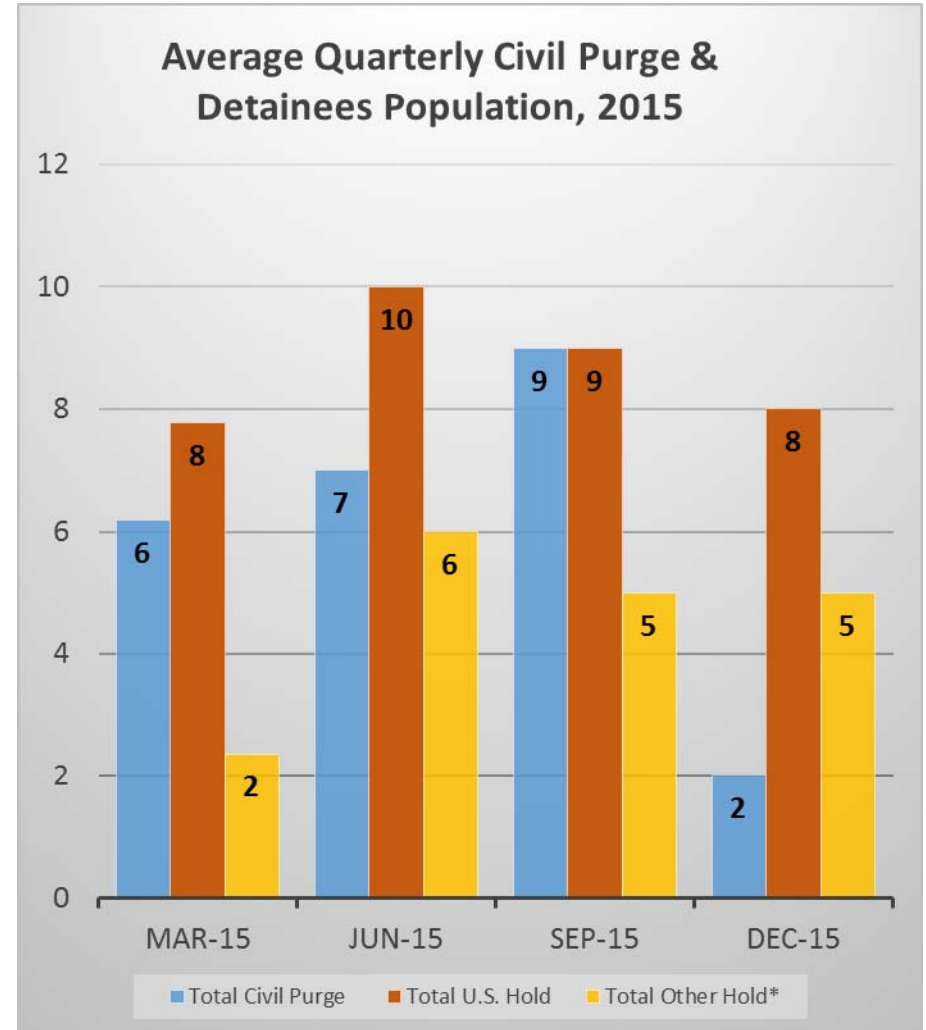
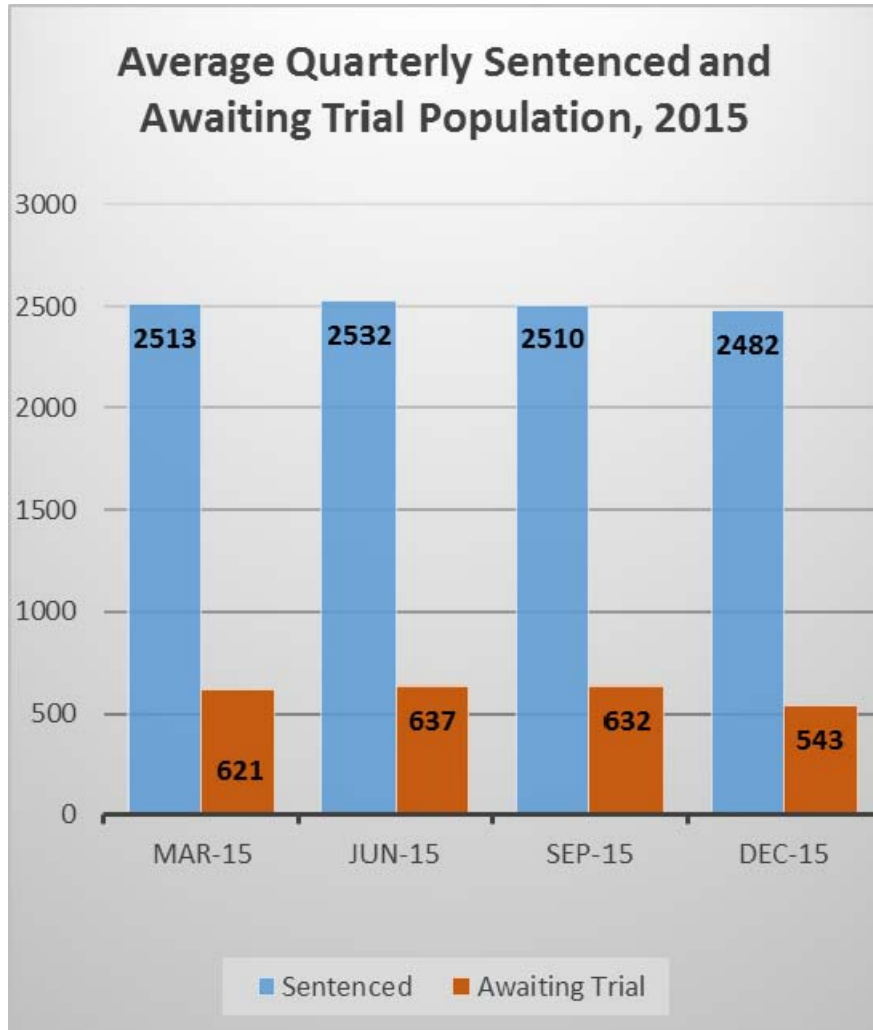
Every month in CY15 had a lower average monthly population than CY14, with the exception of June.

Sentenced & Awaiting Trial, Civil Purge & Detainees



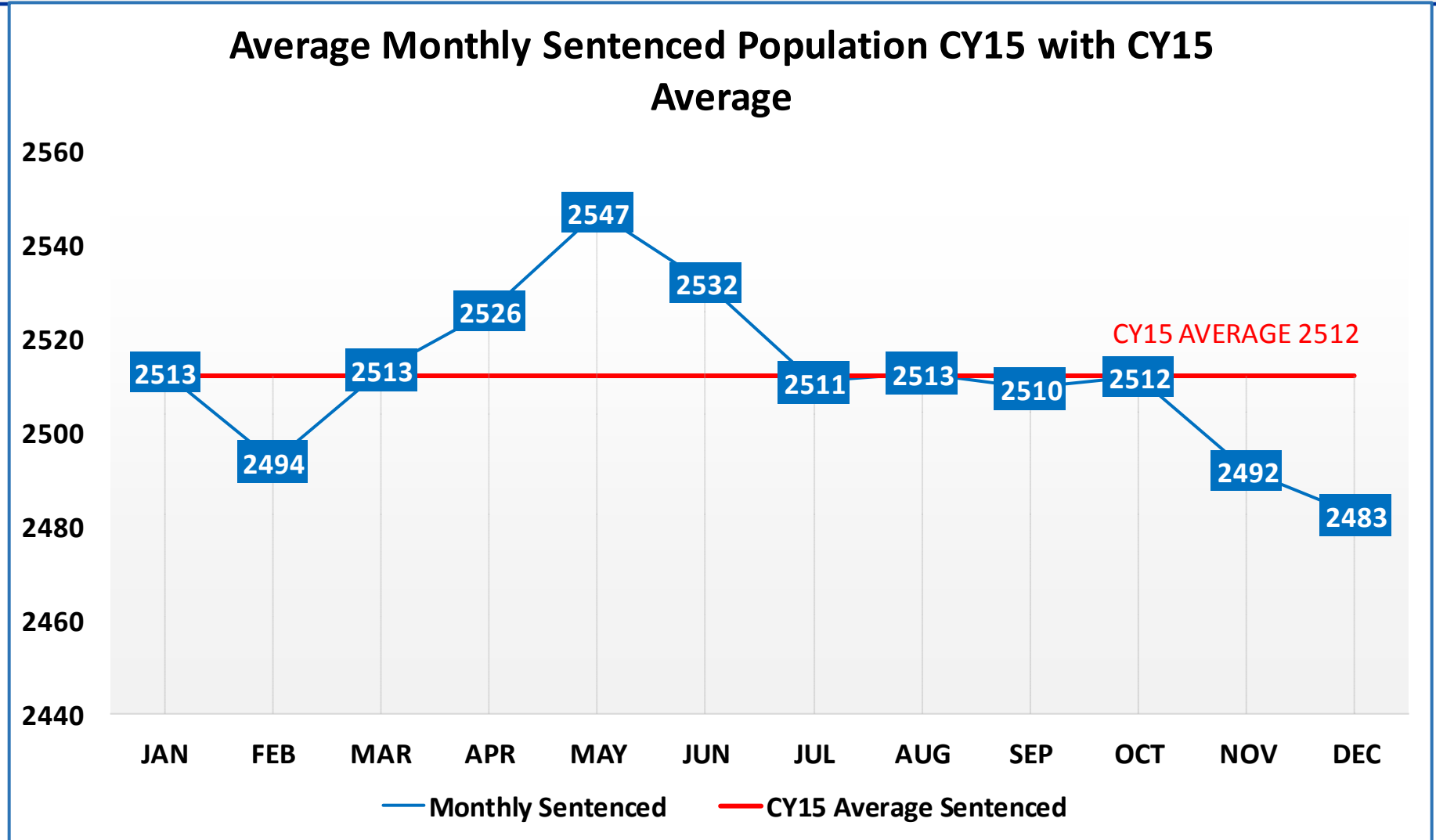

Average Monthly Sentenced Population Calendar Year 2015

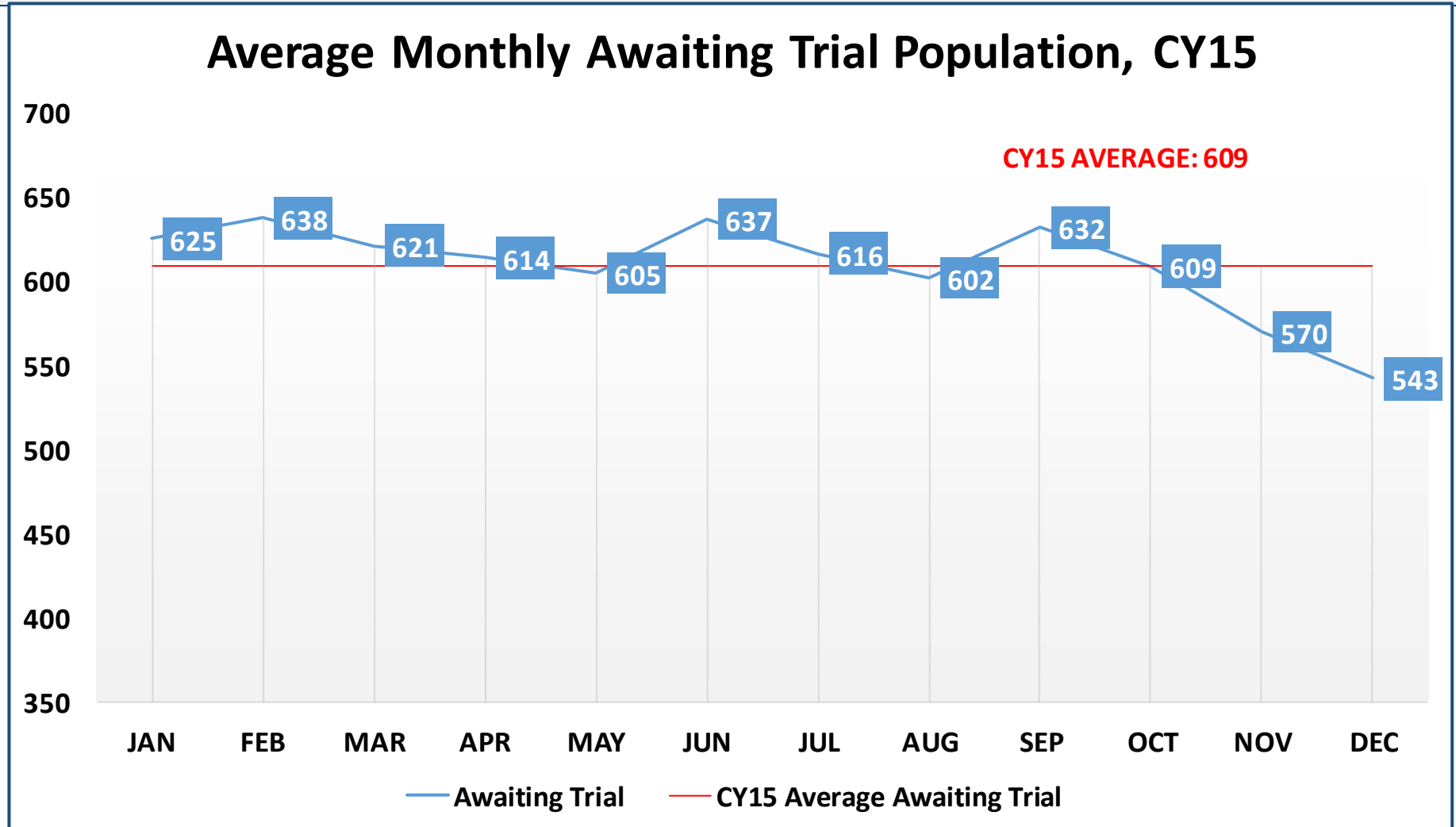
The Average Sentenced Population increased very slightly from 2498 in CY14 to 2512 in CY15, an increase of .56%.





Average Monthly Awaiting Trial Population Calendar Year 2015

The Average Monthly Awaiting Trial Population decreased substantially from 674 in CY14 to 609 in CY15, a decrease of 10.67%.

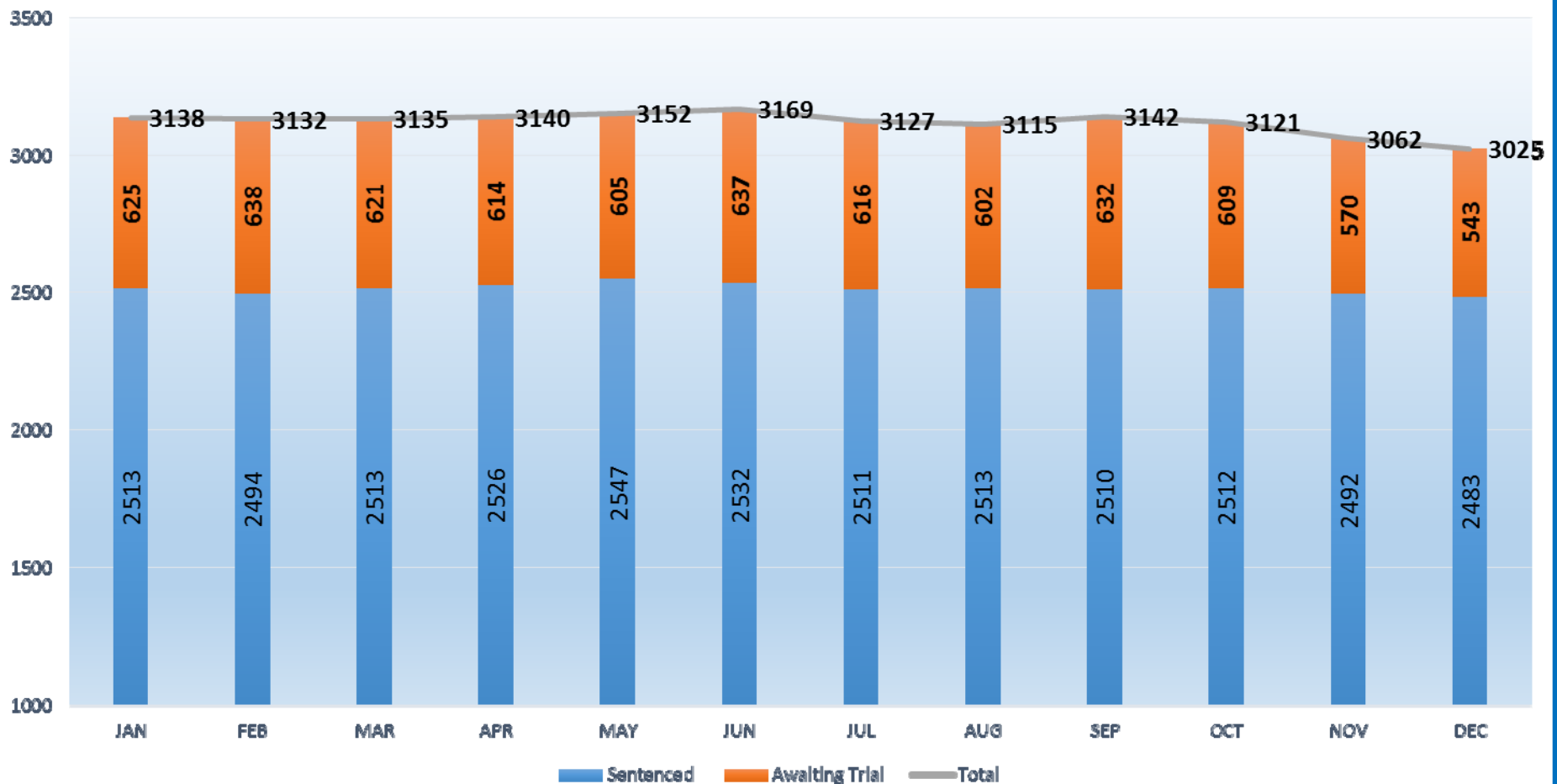




Average Monthly Population CY15 by Status – Awaiting Trial or Sentenced

Average Monthly Sentenced and Awaiting Trial Population, 2015





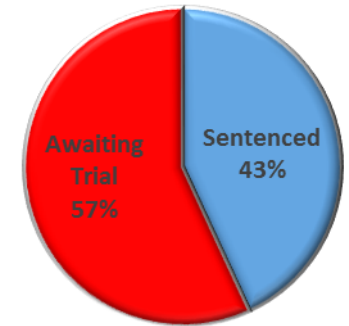

Average Monthly Population CY 2015

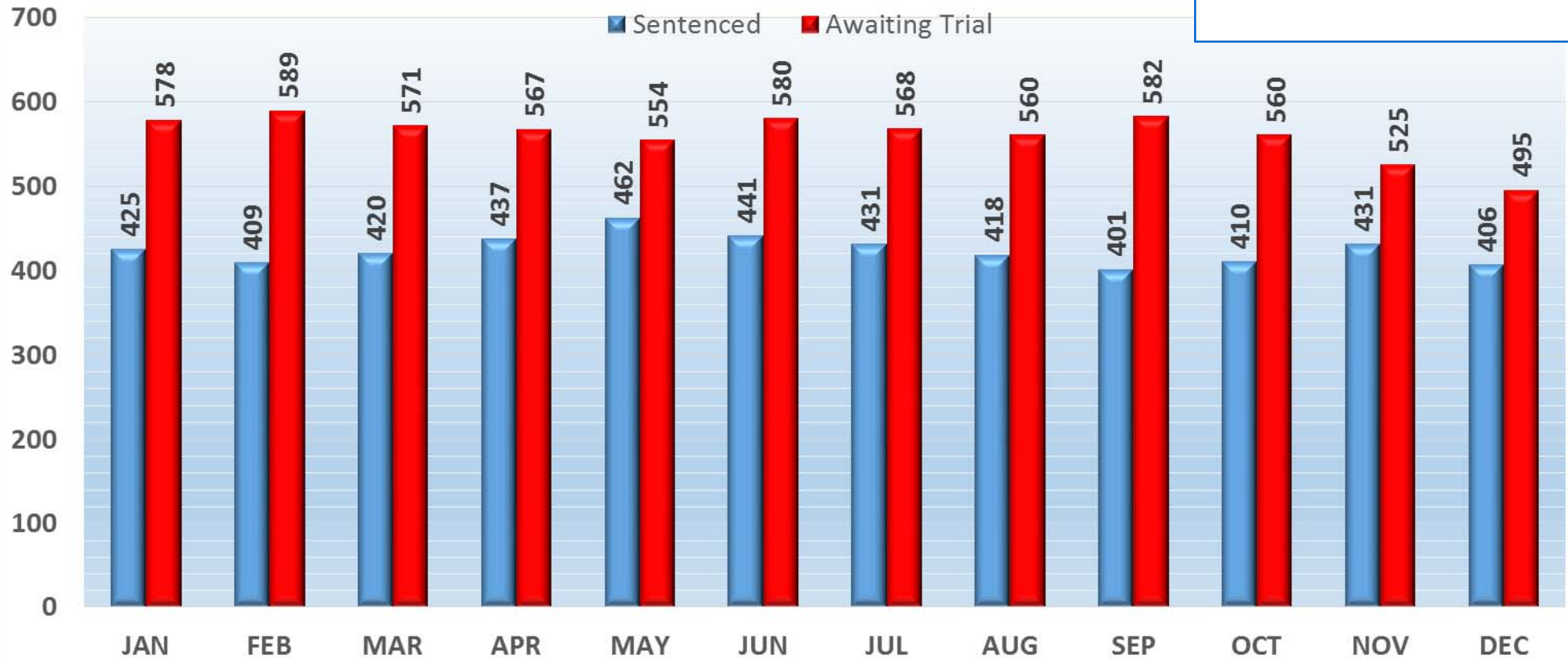

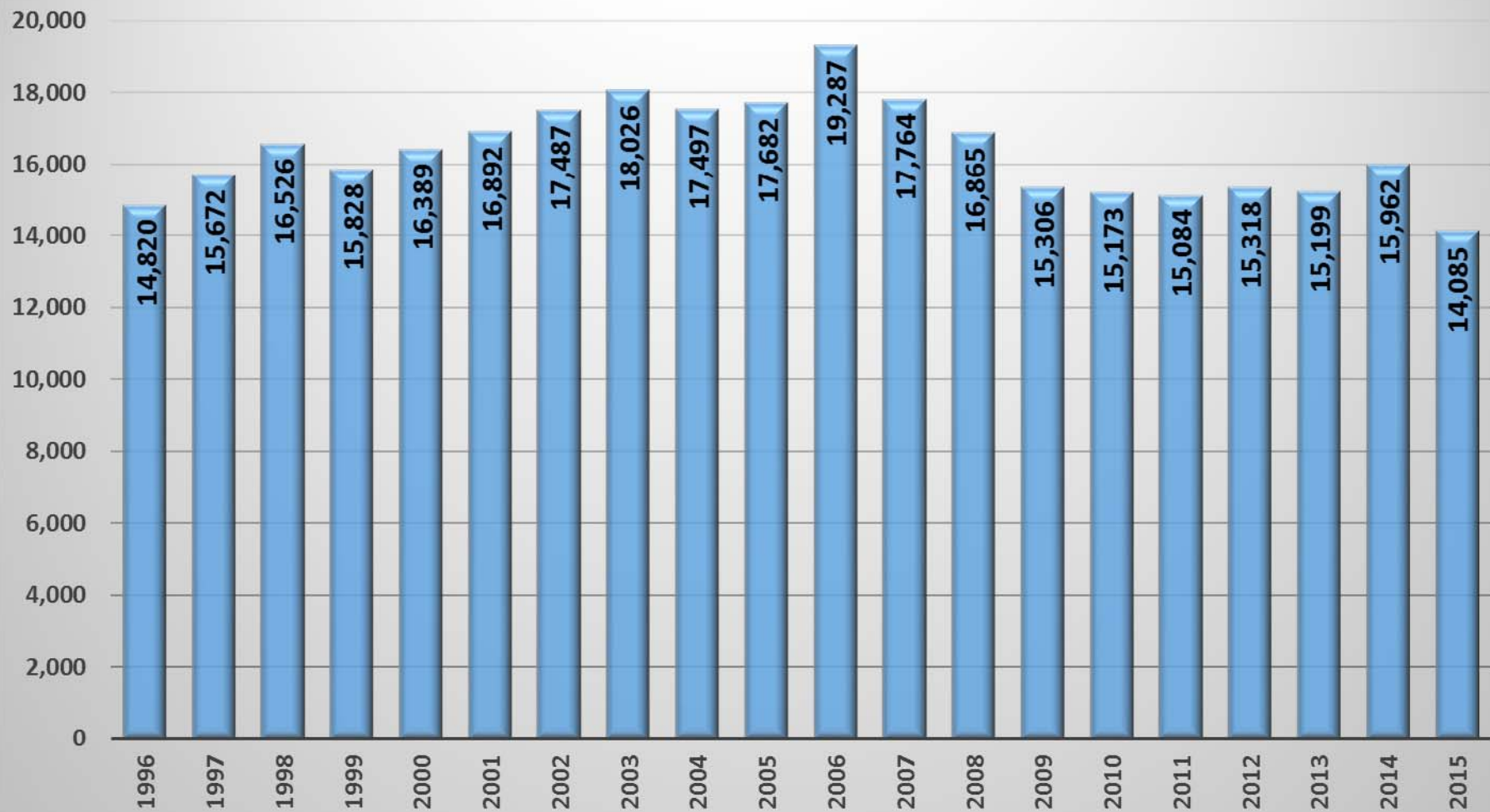


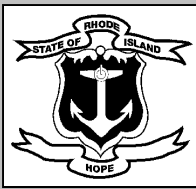


RIDOC Total Commitments CY 1996 – 2015

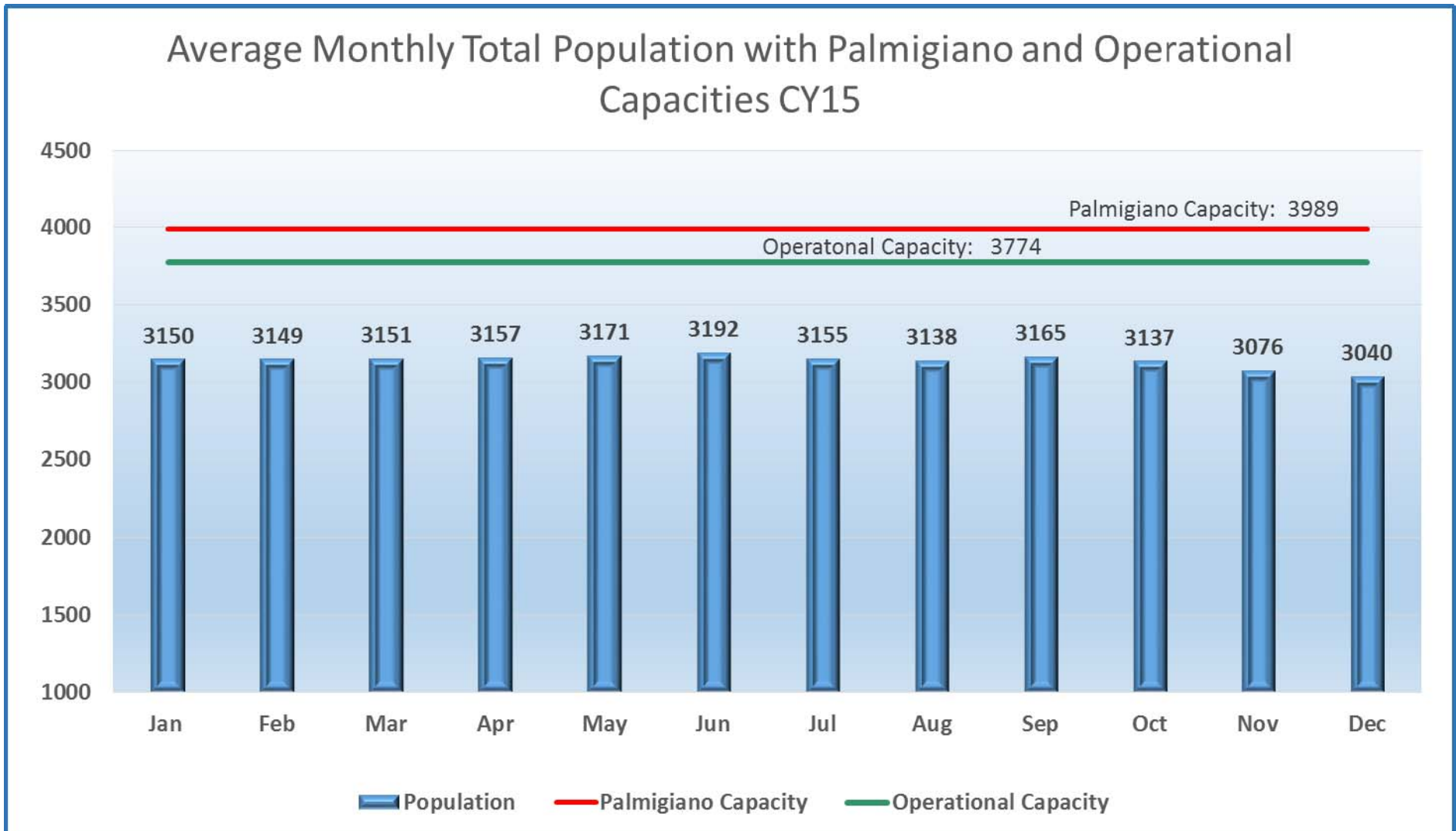
The Total Commitments for CY15 were 14,085. CY15 Commitments are at the lowest point in almost 20 years.

83.2% of Operational Capacity (3774) and 78.7% of Palmigiano Capacity (3989)

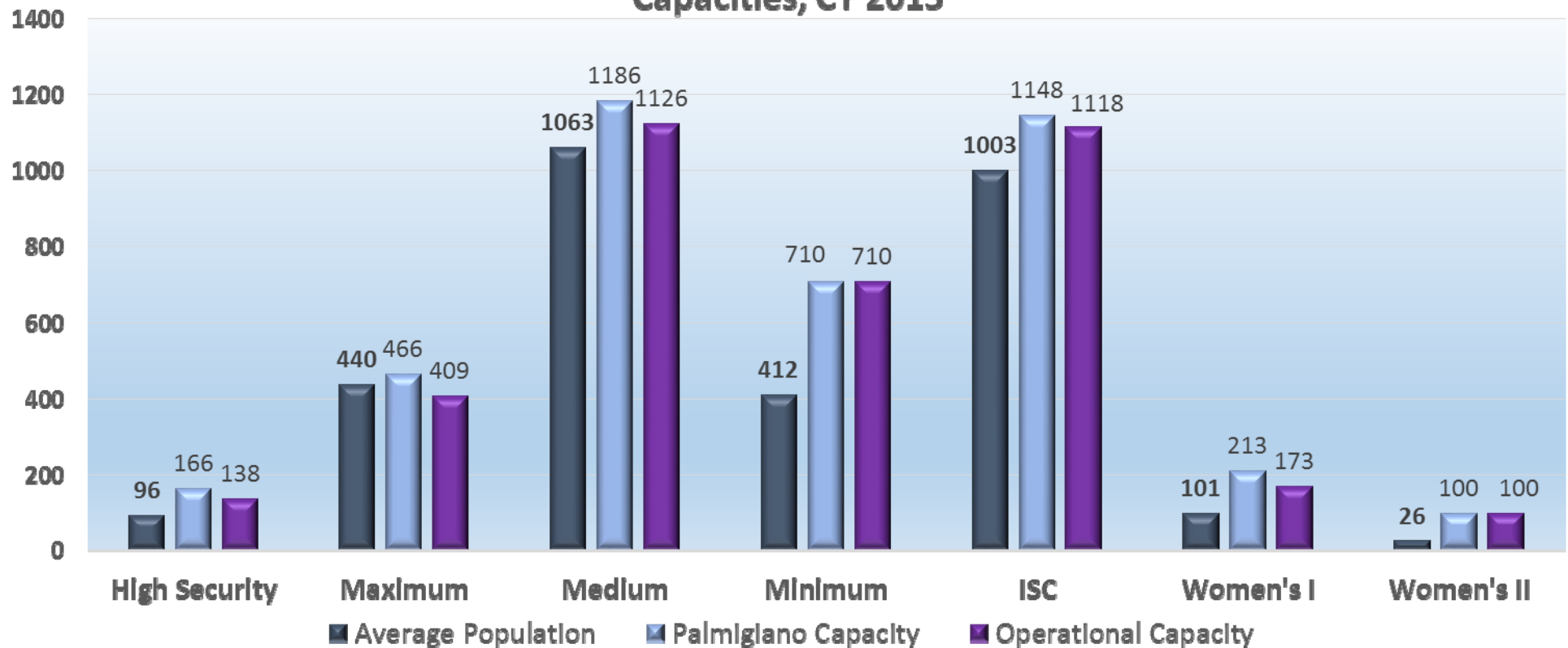

Average Monthly Population by Facility with Palmigiano and Operational Capacities, CY 2015



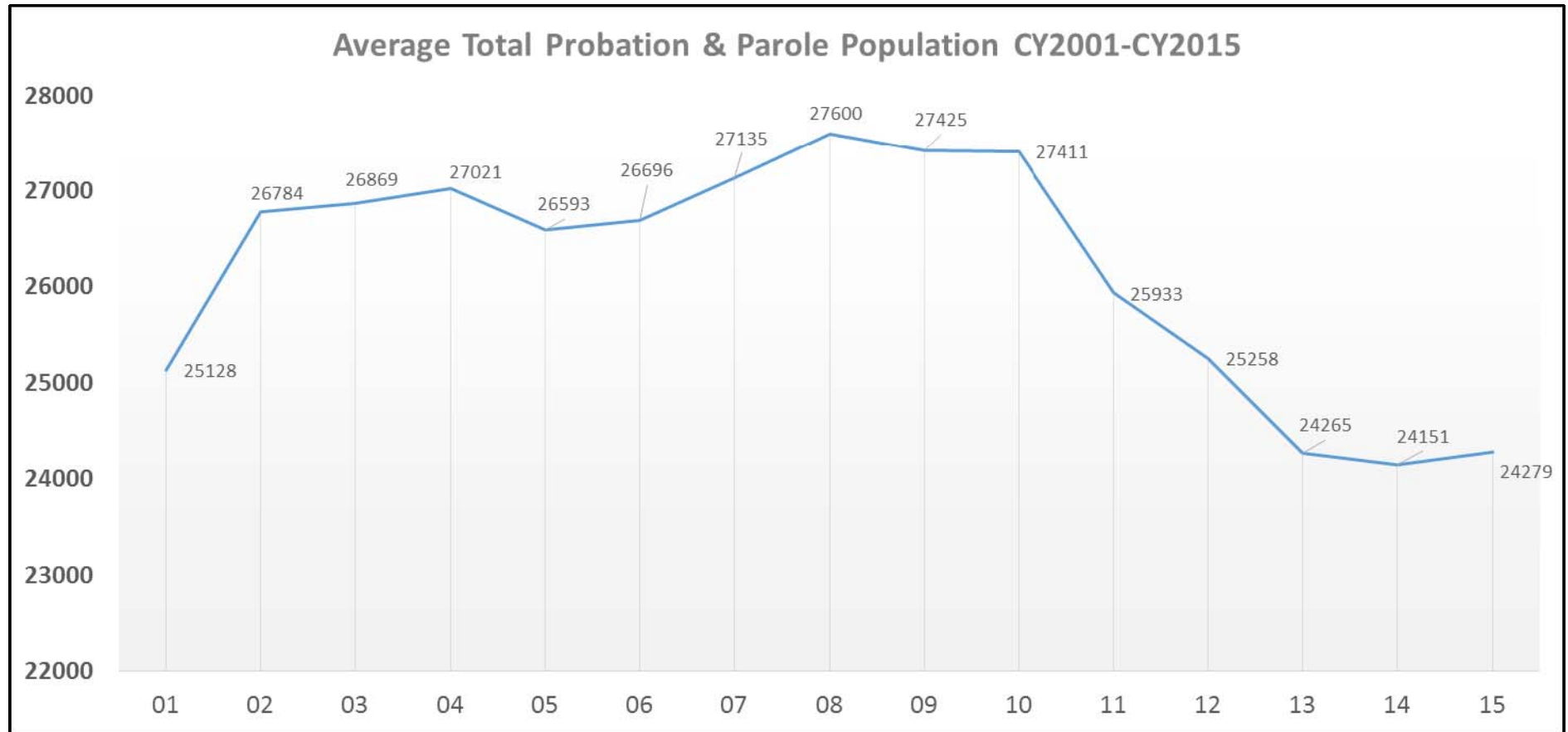


Number of Offenders on Community Supervision per Square Mile as of June 30, 2015





Average Total Probation & Parole Population CY 2001 to CY 2015

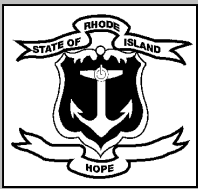


Total population includes active, low and banked supervision cases.
As of December 31, 2015, there were 24,150 RI offenders on Adult Probation & Parole.

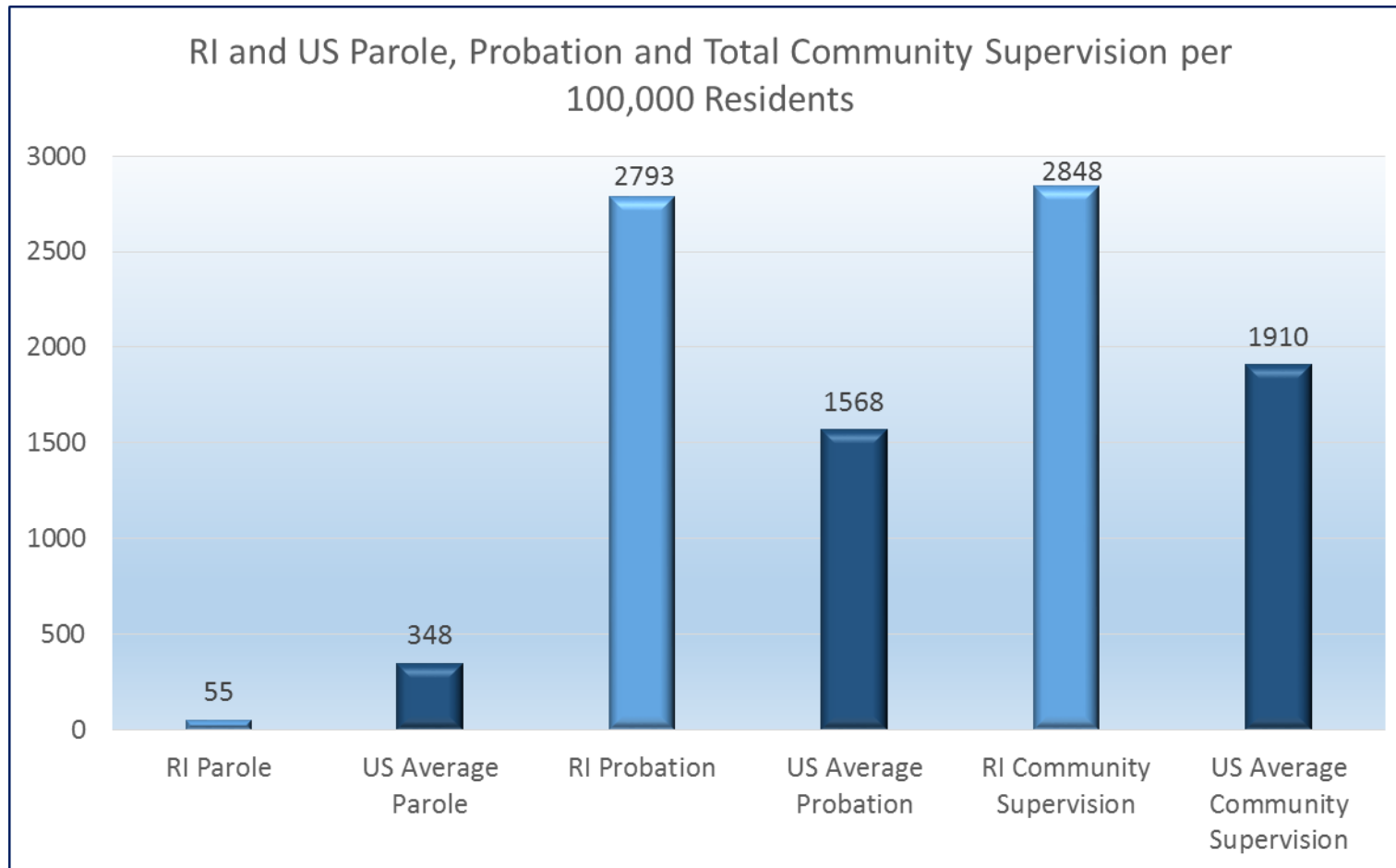
Of those:

- 8,689 were on Active Supervision
- 1,344 were on Low Supervision (offenders who have at least one open indictment, but are NOT reporting to or in regular contact with a probation or parole officer)
- 13,201 were Banked Cases (not actively supervised includes Superior and District Court banked, active warrant, trouble free, incarcerated, court-ordered unsupervised, pending transfer, deported, paroled to immigration and pending interstate cases)
- 32 Total RI Parole Cases supervised in other states
- 884 Total RI Probation Cases supervised in other states

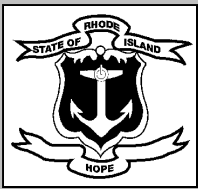




Average Total Community Confinement Population CY96 to CY15

RI Inmates Serving Life or Life without Parole

- As of December 31, 2015 there were 32 Rhode Island inmates serving a sentence of Life without Parole (5 were serving out-of-state).
- As of December 31, 2015 there were 197 Rhode Island inmates serving a Life Sentence* (18 were serving out-of-state and 2 were Dual Lifers).

* this total **excludes** 18 Out of State Lifers (OOS Lifer) serving another state's sentence in RI according to interstate compact and **includes** Dual Lifers which are inmates serving multiple states' sentences
