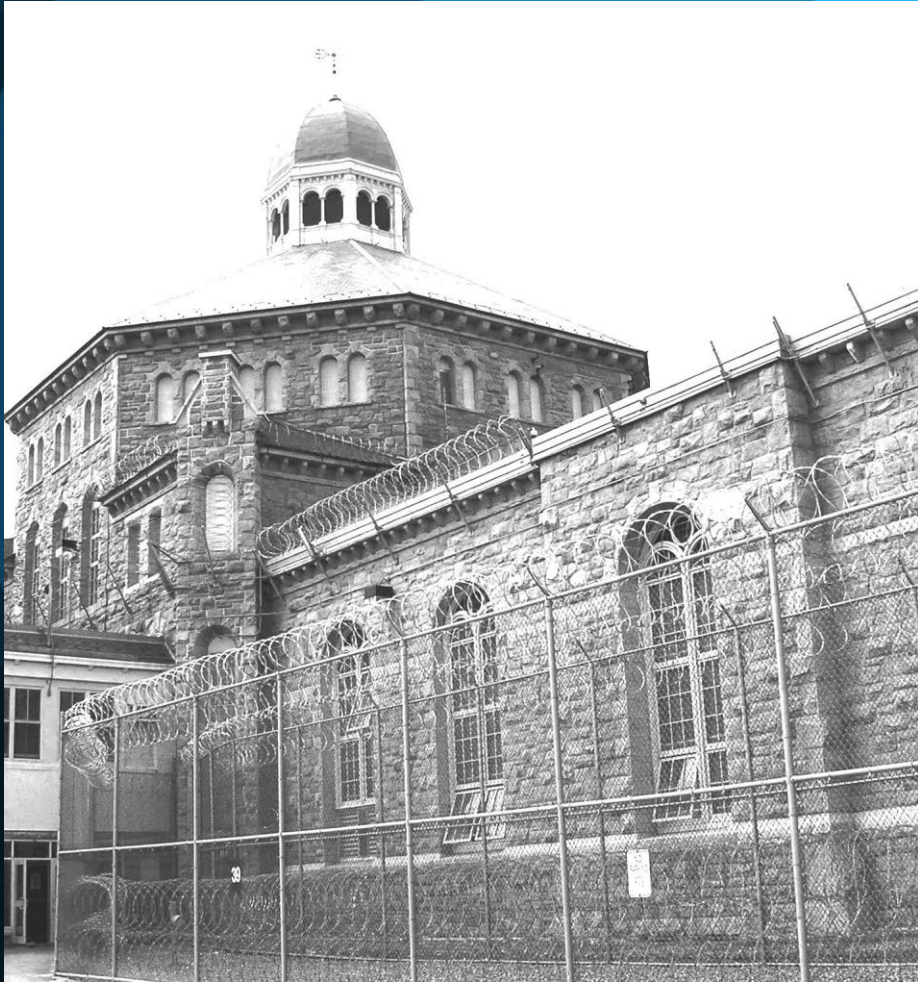

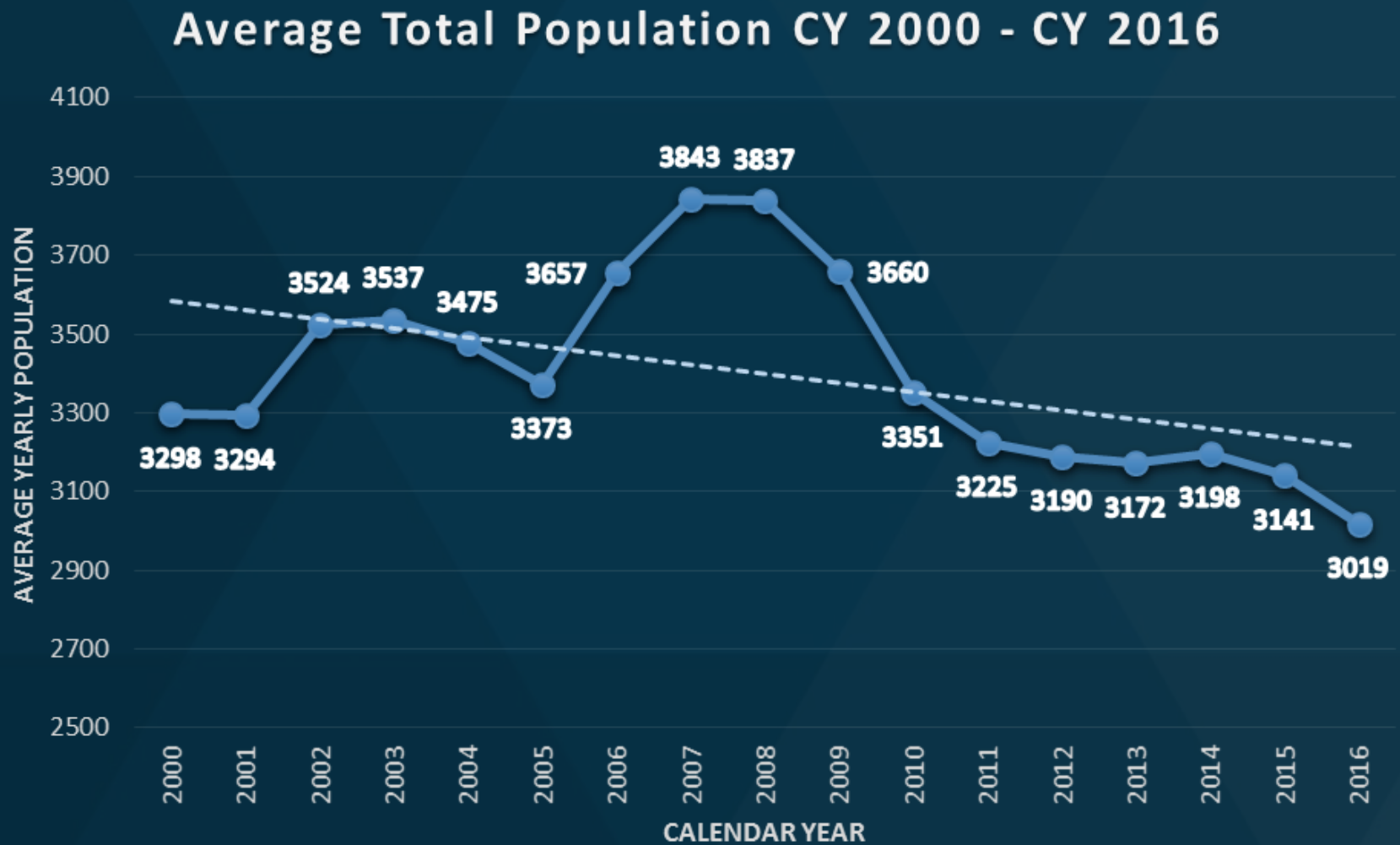

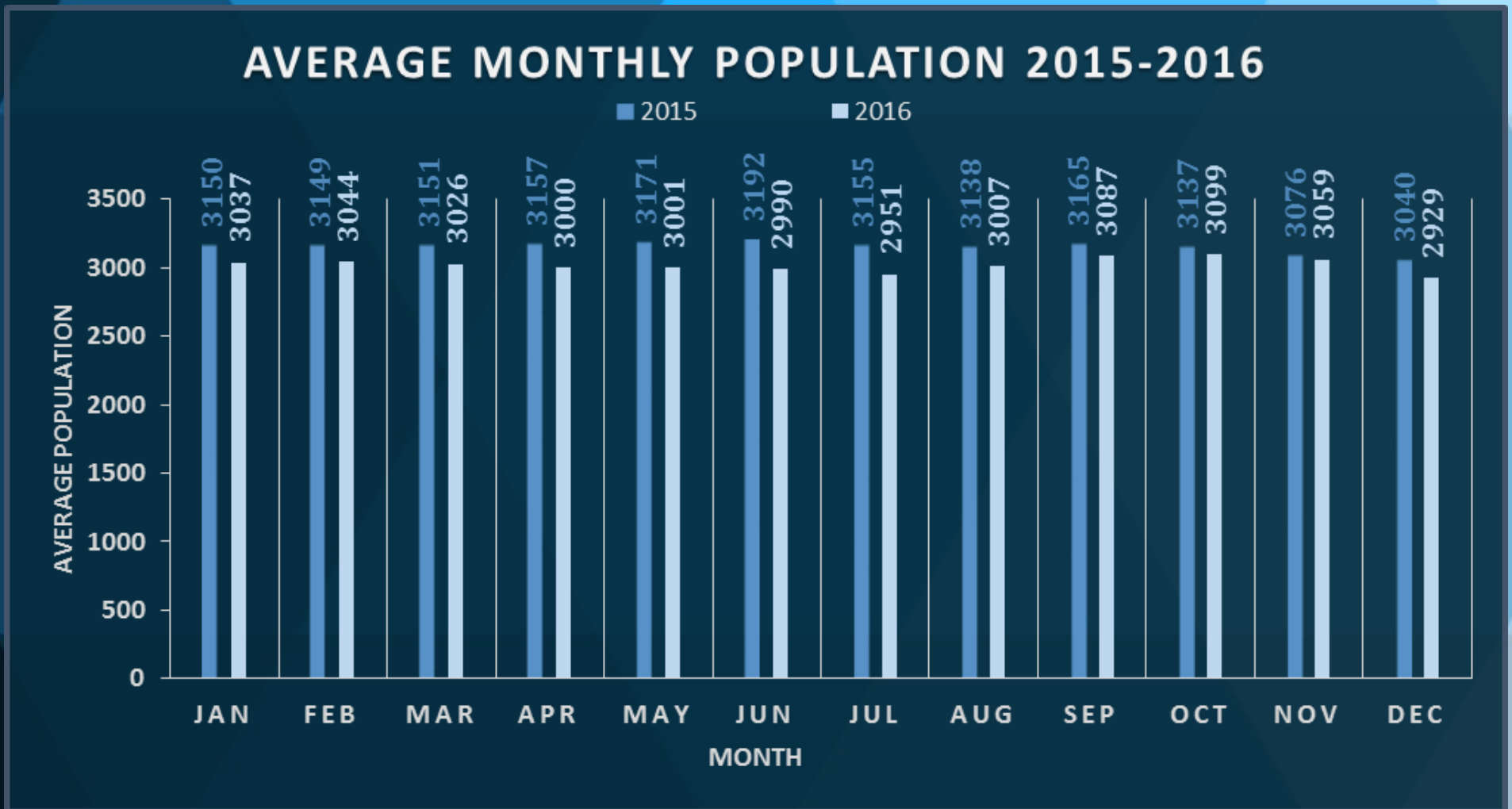


AVERAGE TOTAL POPULATION CY 2000 TO CY 2016





AVERAGE TOTAL POPULATION BY MONTH CALENDAR YEARS 2015-2016

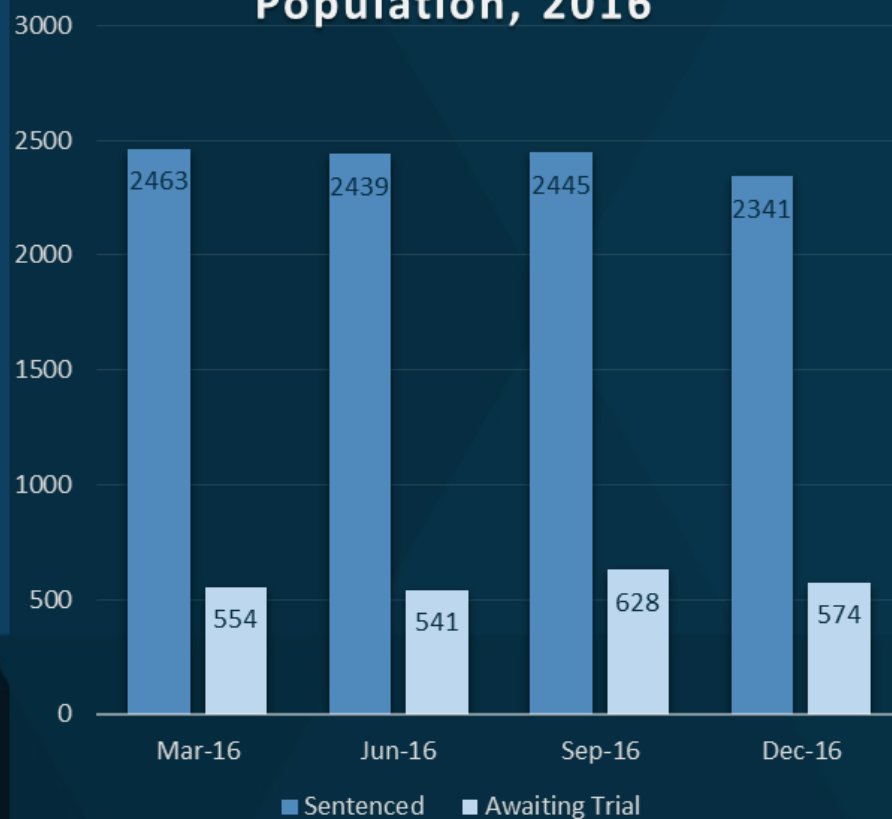


Every month in CY16 had a lower average monthly population than CY15.

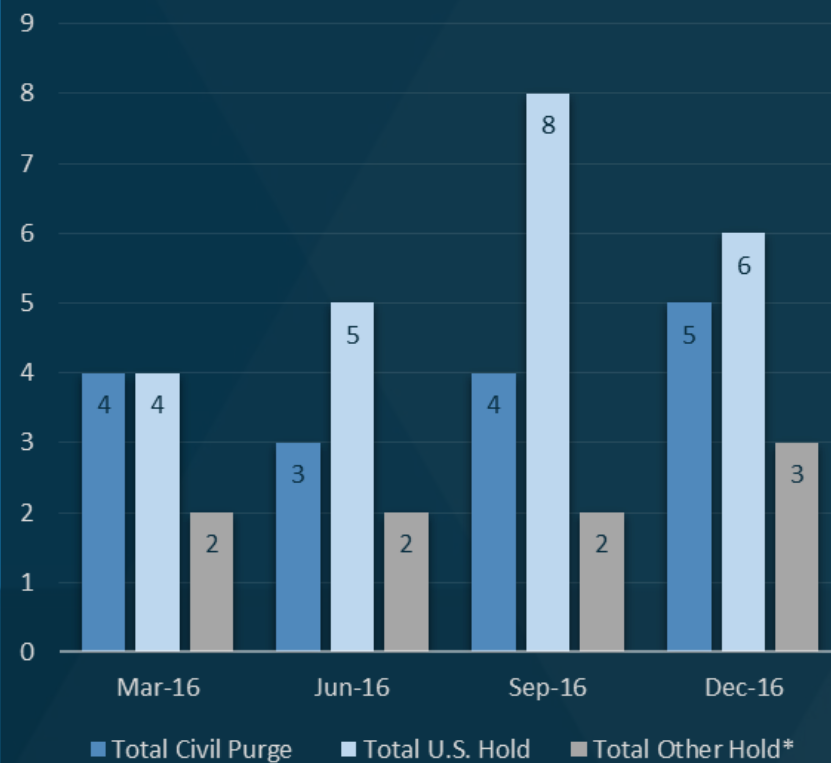


CY16: SENTENCED & AWAITING TRIAL, CIVIL PURGE & DETAINEES

Average Quarterly Sentenced and Awaiting Trial Population, 2016



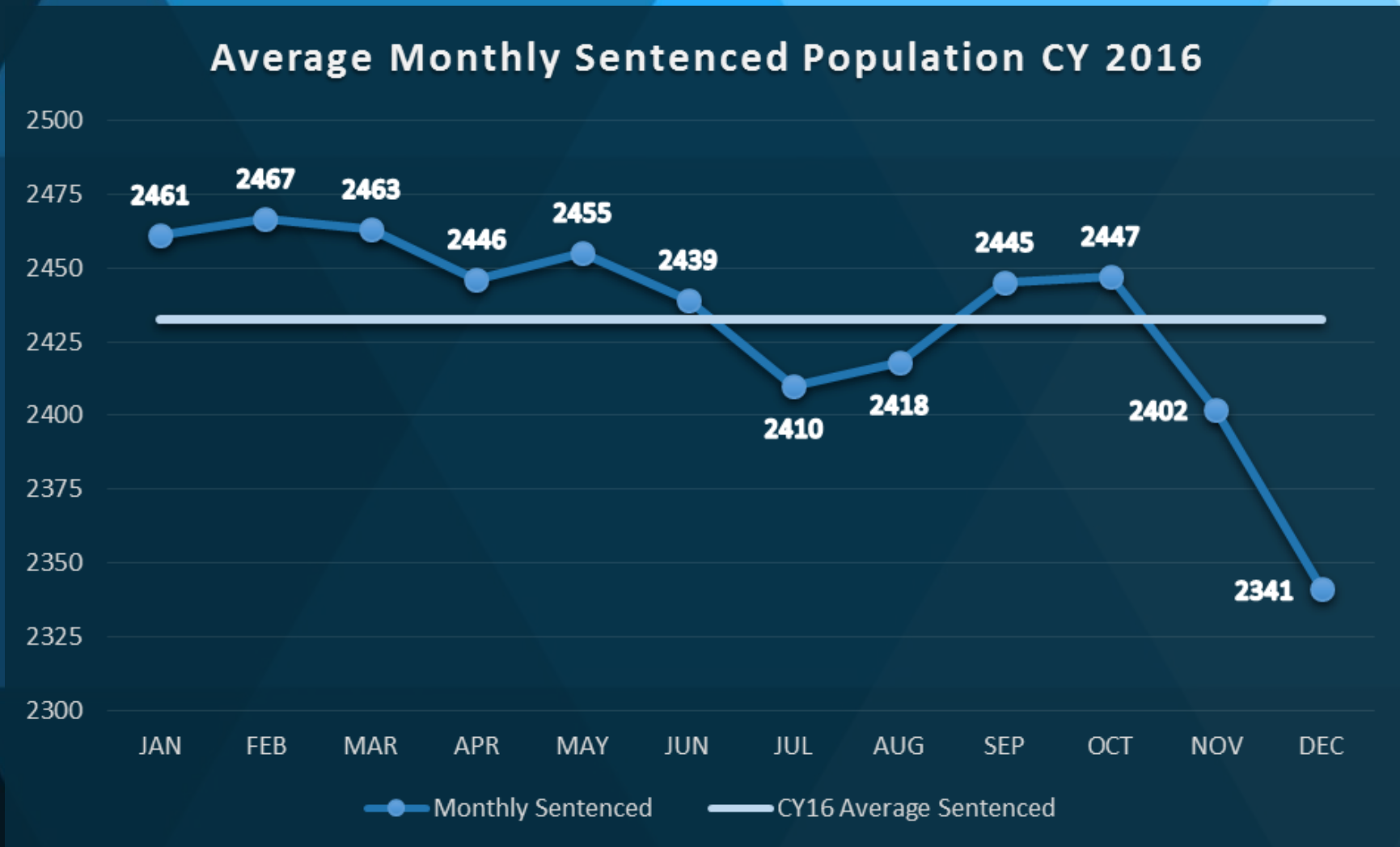
Average Quarterly Civil Purge & Detainees Population, 2016

AVERAGE MONTHLY SENTENCED POPULATION CALENDAR YEAR 2016

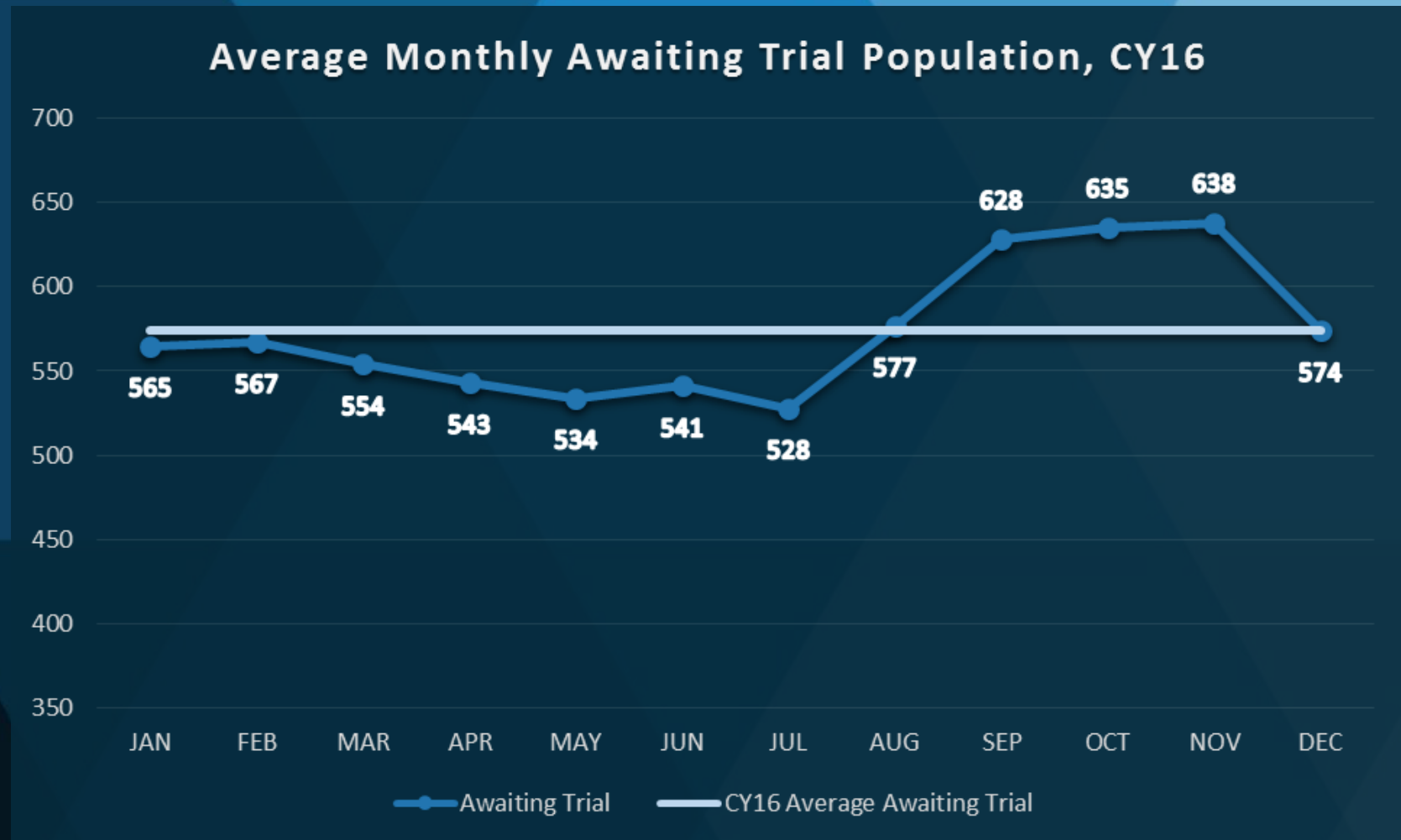


The Average Sentenced Population decreased 4.9% from the beginning of CY16 to the end.



AVERAGE MONTHLY AWAITING TRIAL POPULATION CALENDAR YEAR 2016

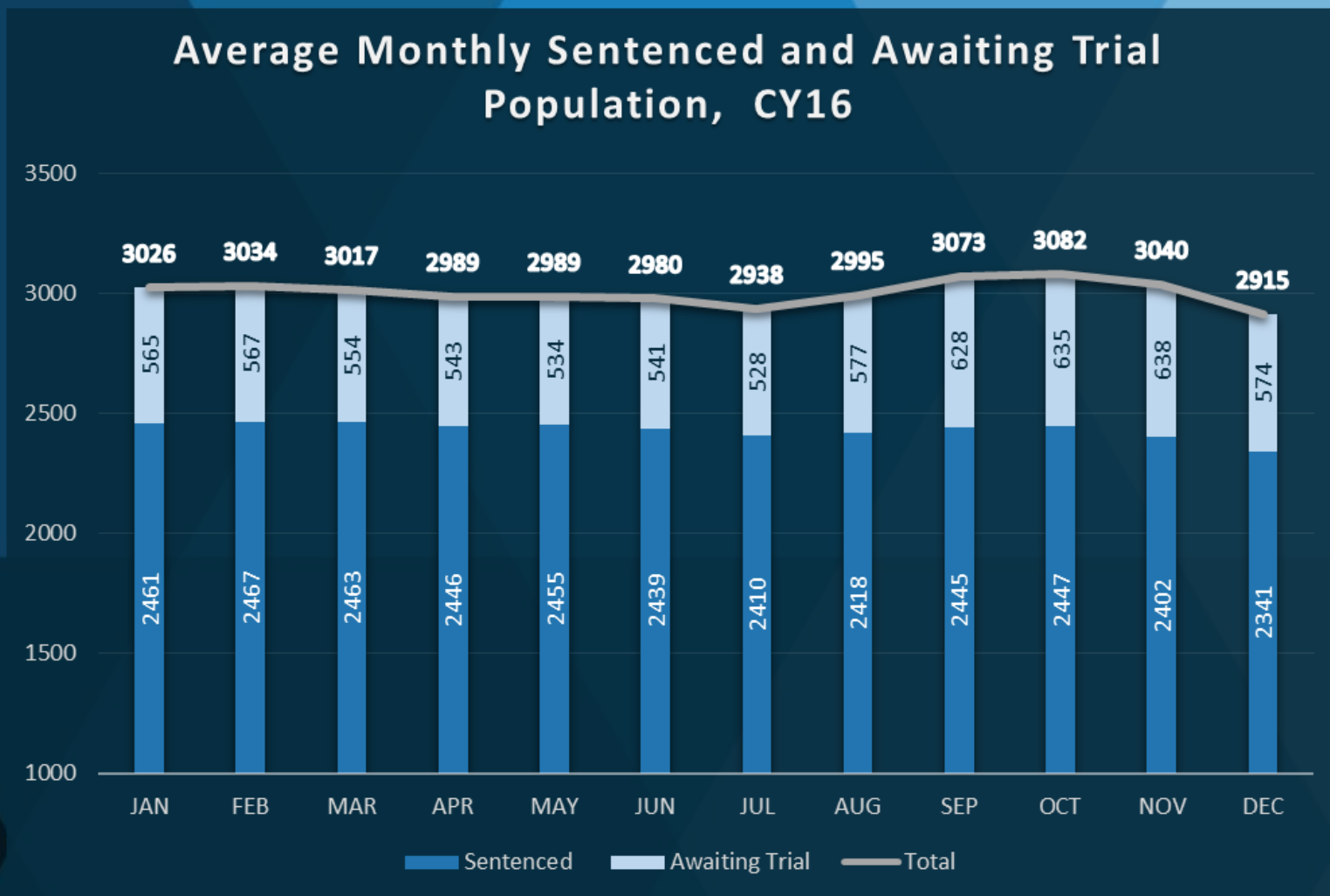
The Average Monthly Awaiting Trial Population decreased from 609 in CY15 to 574 in CY16, a decrease of 5.75%.





AVERAGE MONTHLY POPULATION CY16 BY STATUS — AWAITING TRIAL OR SENTENCED

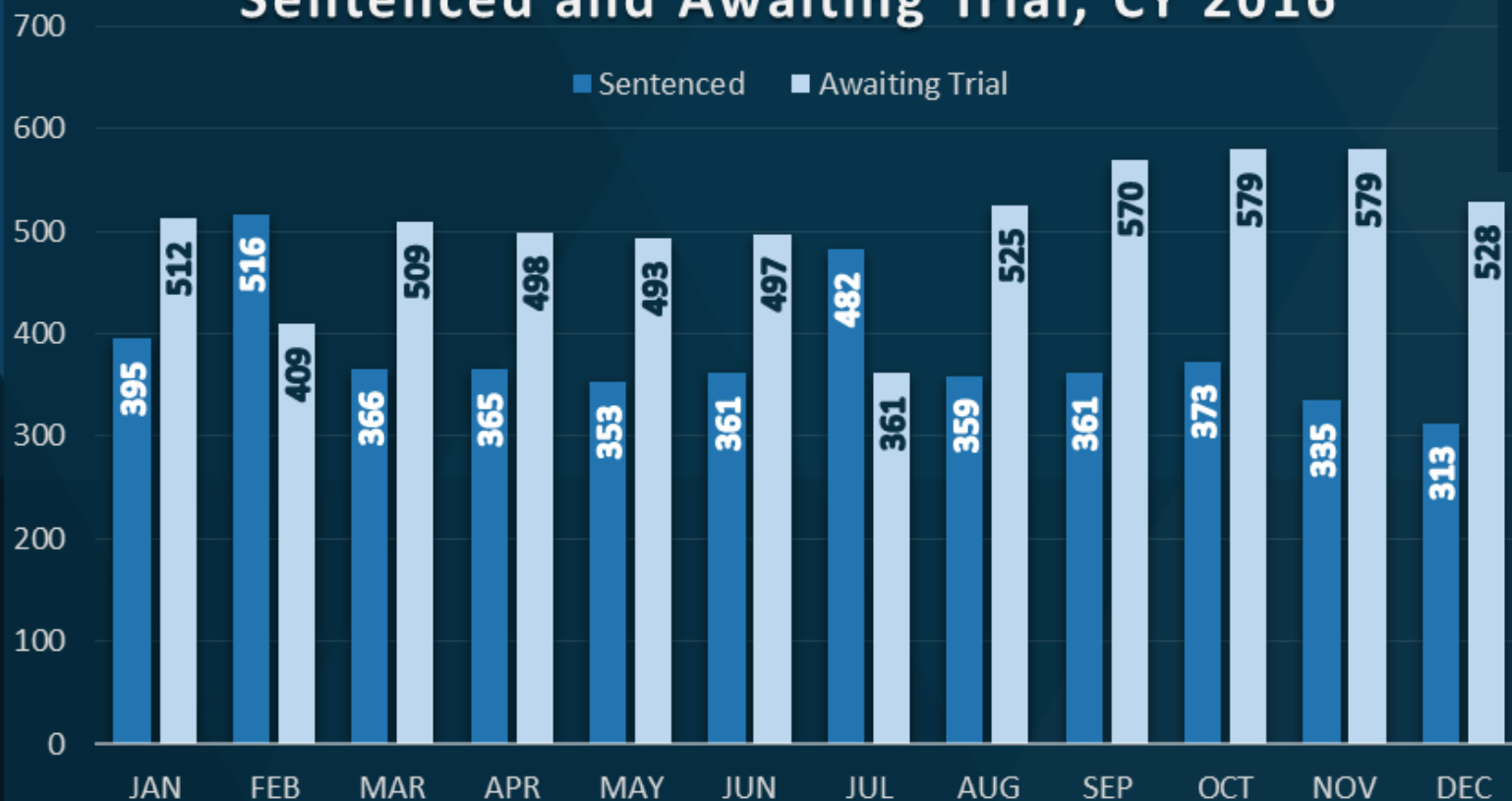
The Average Monthly Sentenced Population for CY16 was 2433 and the Average Monthly Awaiting Trial Population for CY16 was 574.



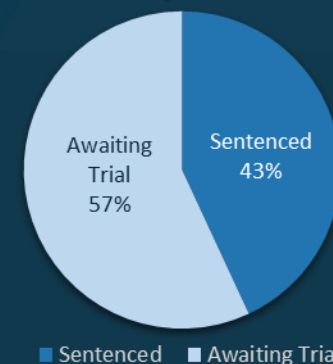

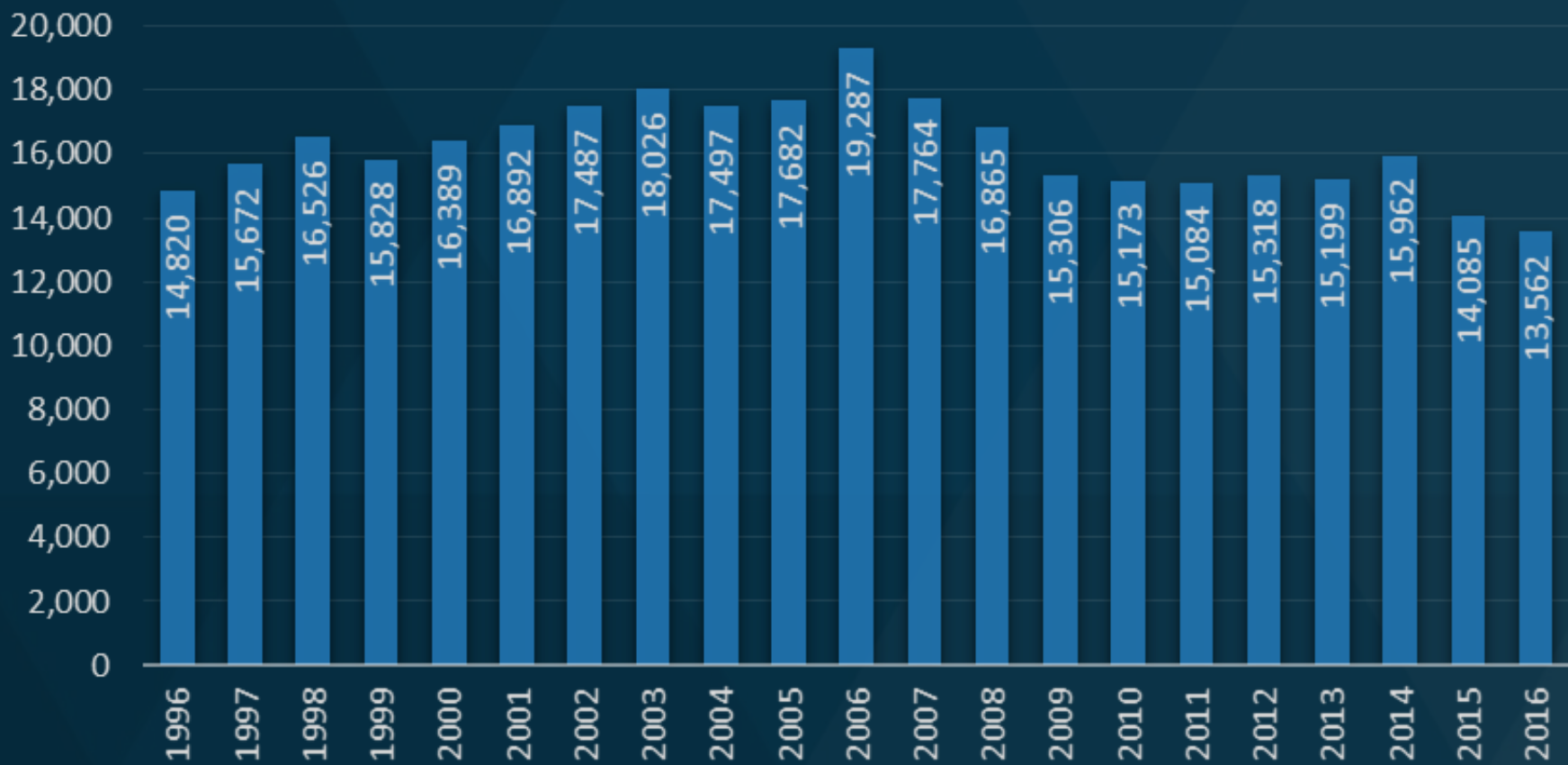

RIDOC TOTAL COMMITMENTS CY 1996 – 2016

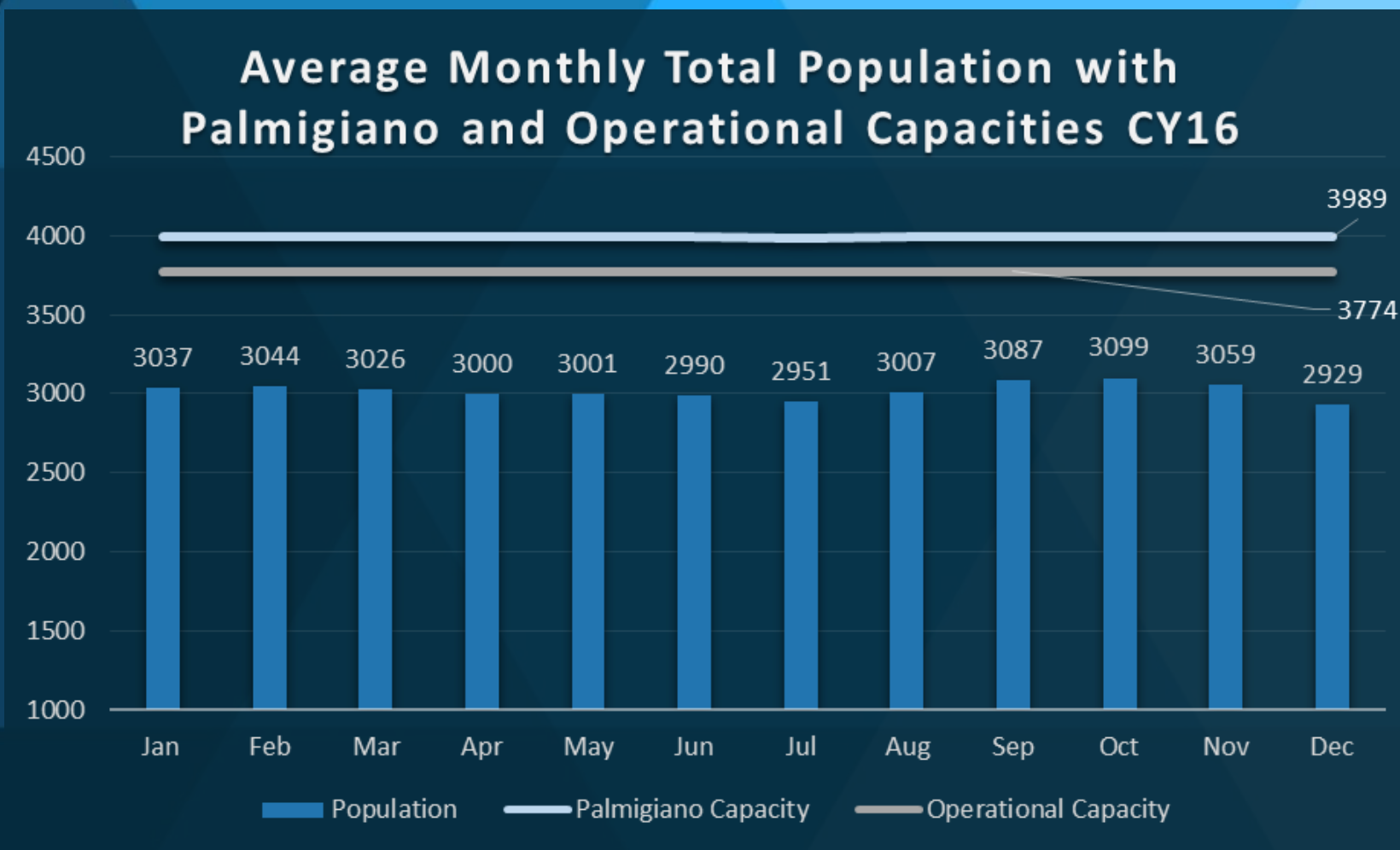
The Total Commitments for CY16 were 13562 which is the lowest point in 20 years.

POPULATION VS. OPERATIONAL & FEDERAL CAPACITY CY 2016



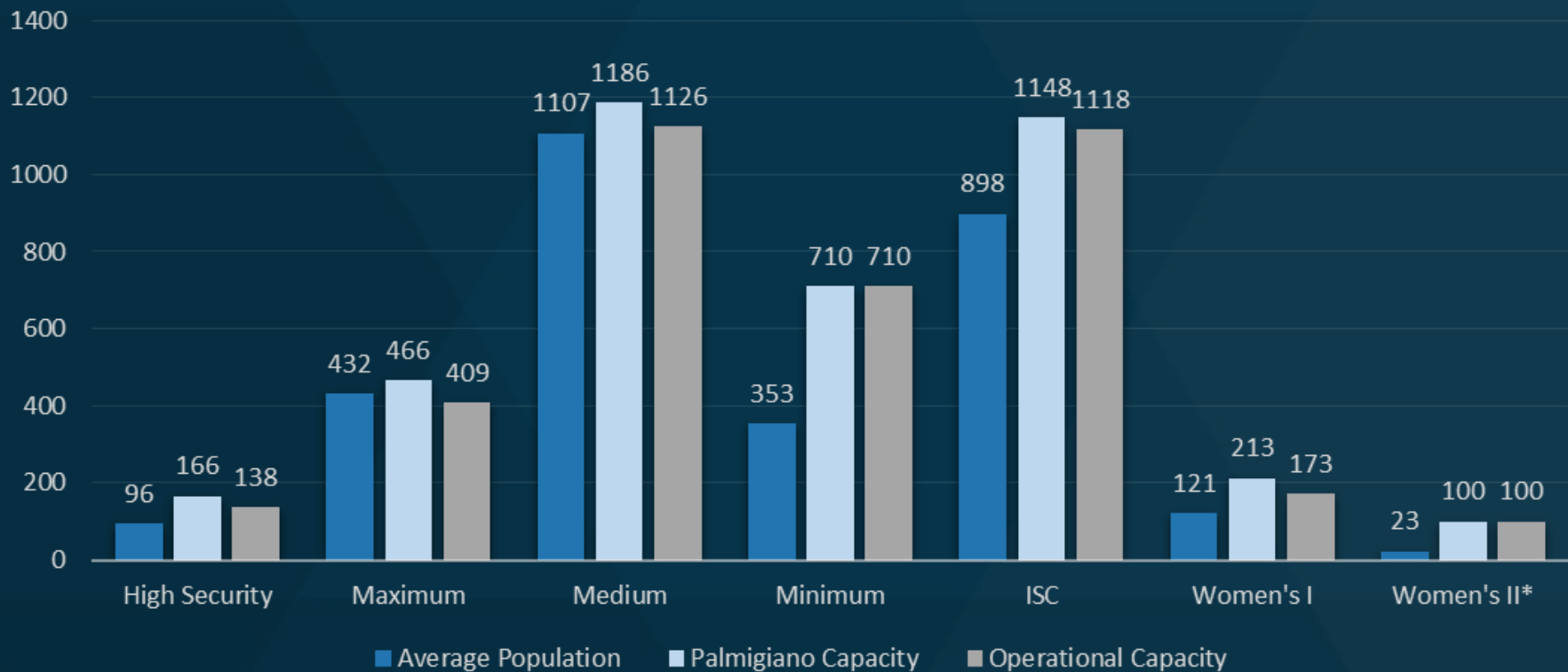

Average Monthly Population by Facility with Palmigiano and Operational Capacities, CY16



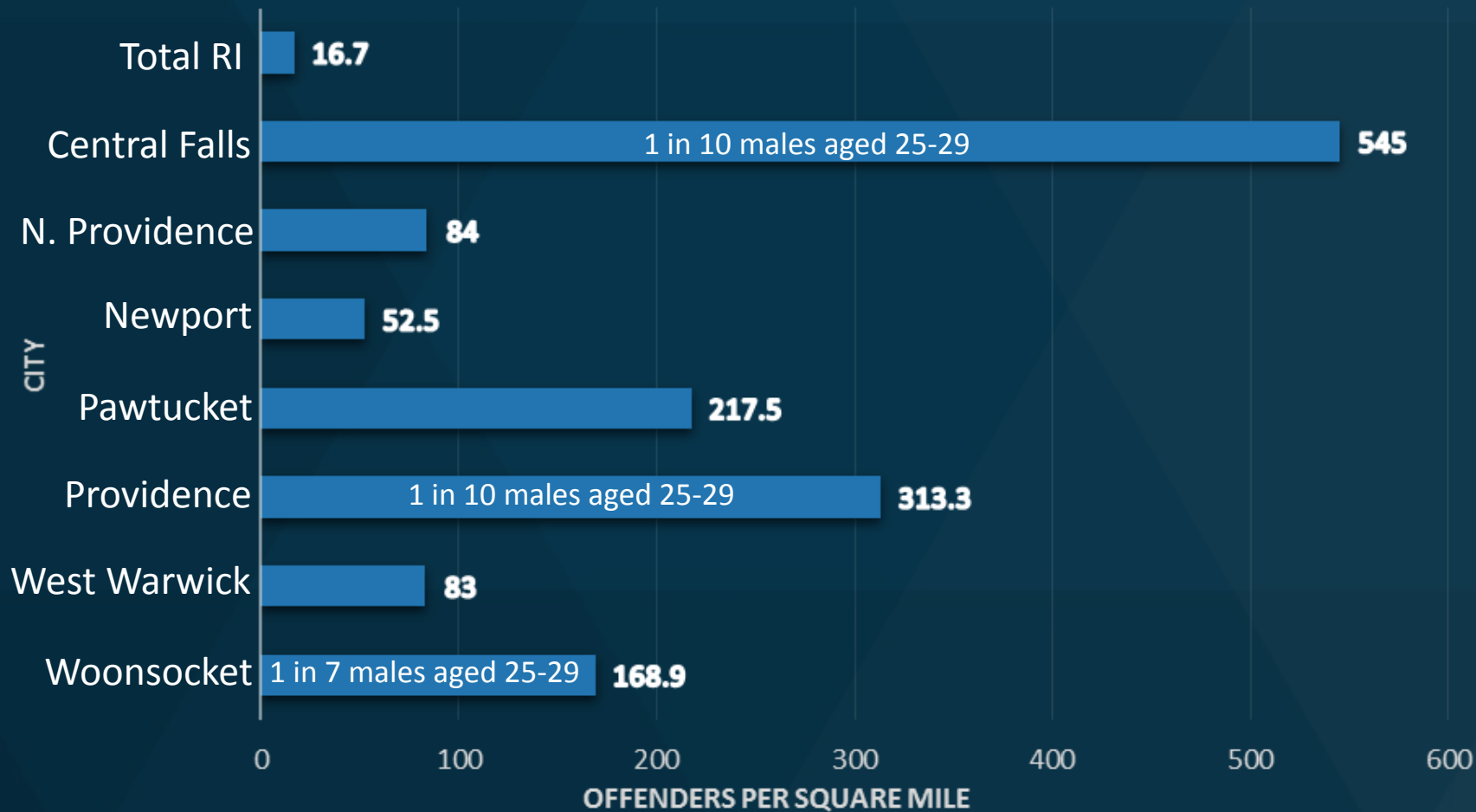

Offenders Per Square Mile

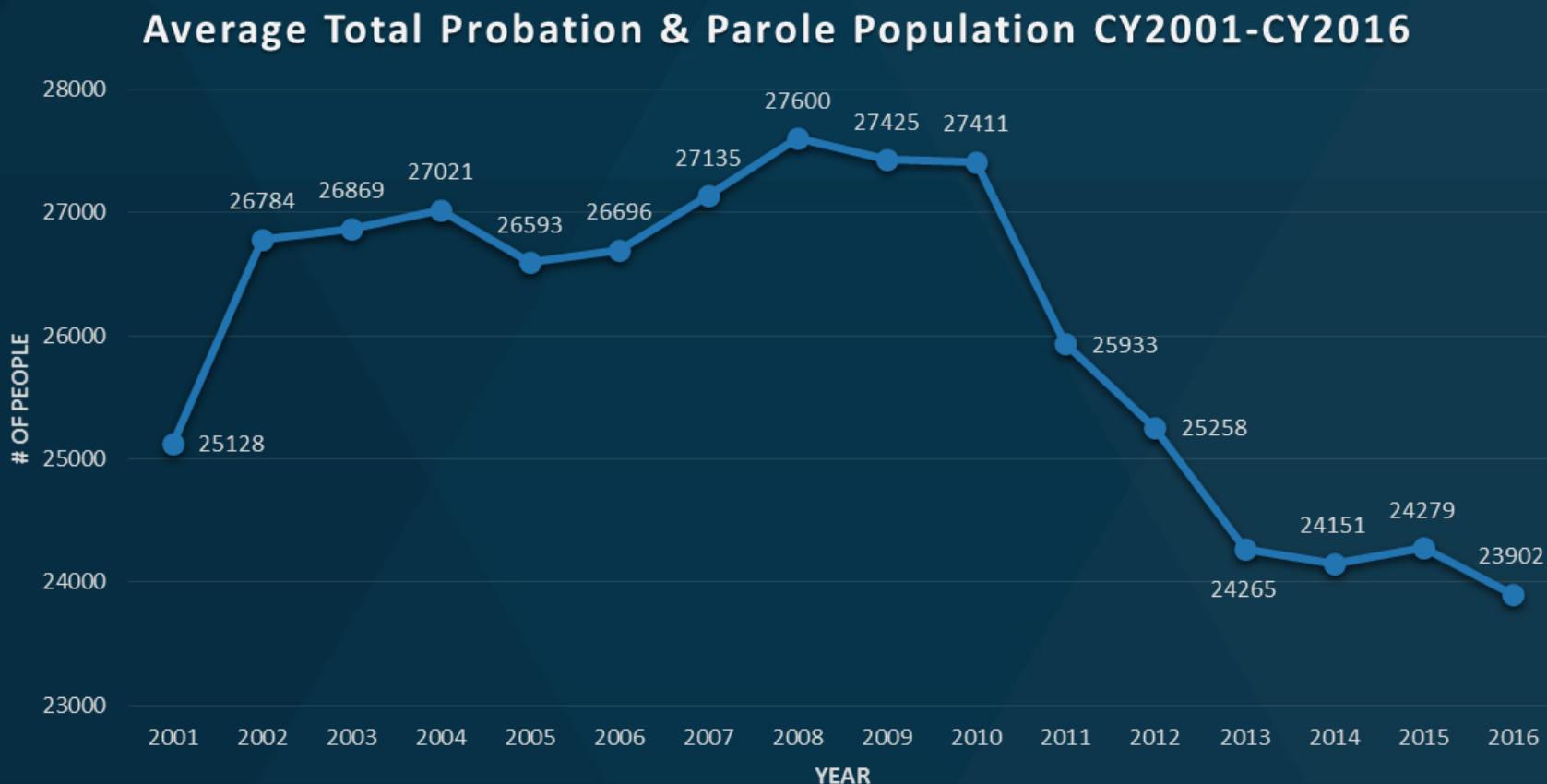


1 out of every 47 adult residents in RI is on probation or parole.

Total population includes active, low and banked supervision cases.

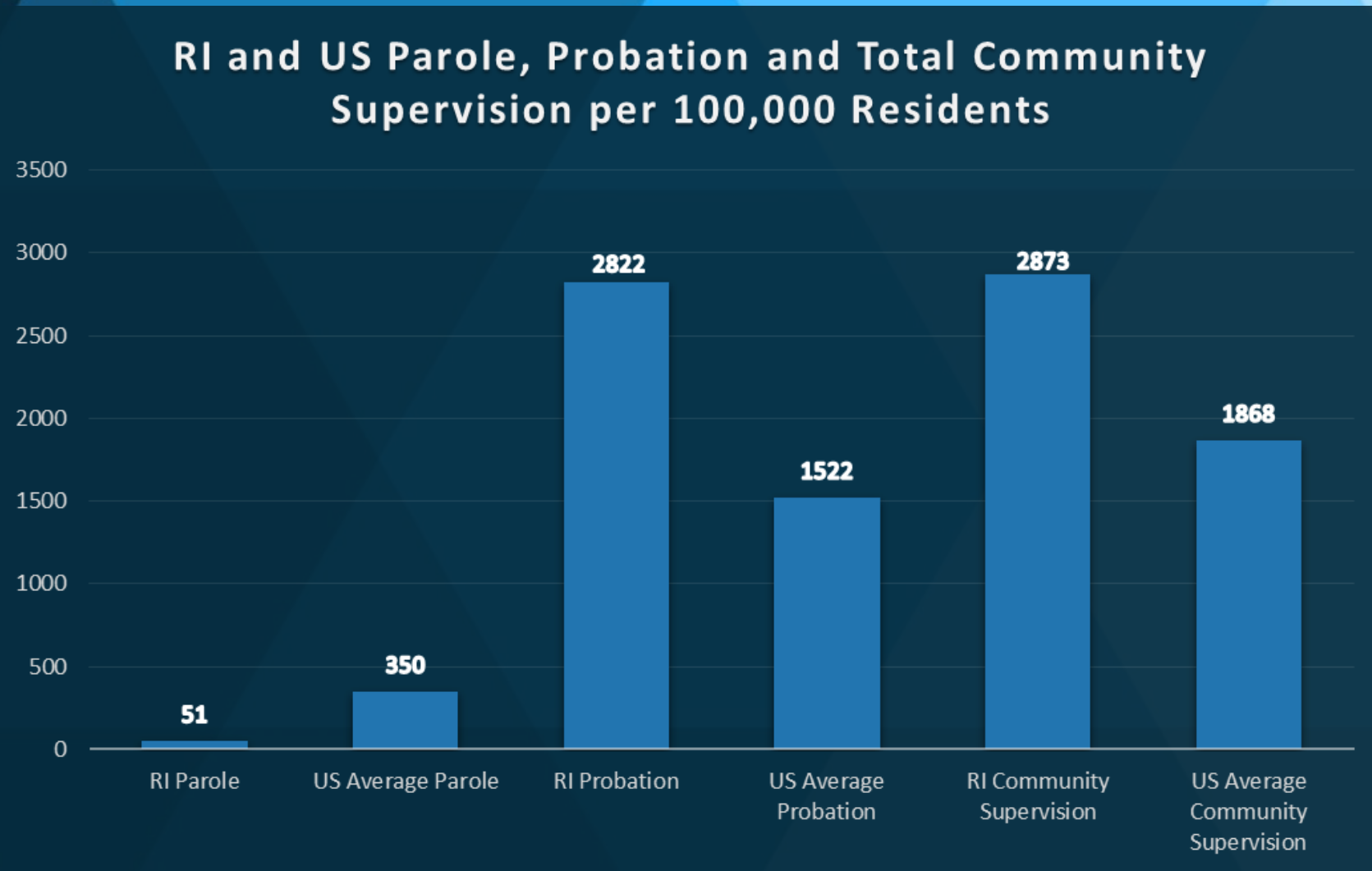
As of December 31, 2016, there were 23,782 RI offenders on Adult Probation & Parole.

Of those:

- 8,675 were on Active Supervision
- 1,962 were on Low Supervision (offenders who have at least one open indictment, but are NOT reporting to or in regular contact with a probation or parole officer)
- 13,145 were Banked Cases (not actively supervised includes Superior and District Court banked, active warrant, trouble free, incarcerated, court-ordered unsupervised, pending transfer, deported, paroled to immigration and pending interstate cases)
- 36 Total RI Parole Cases supervised in other states
- 940 Total RI Probation Cases supervised in other states



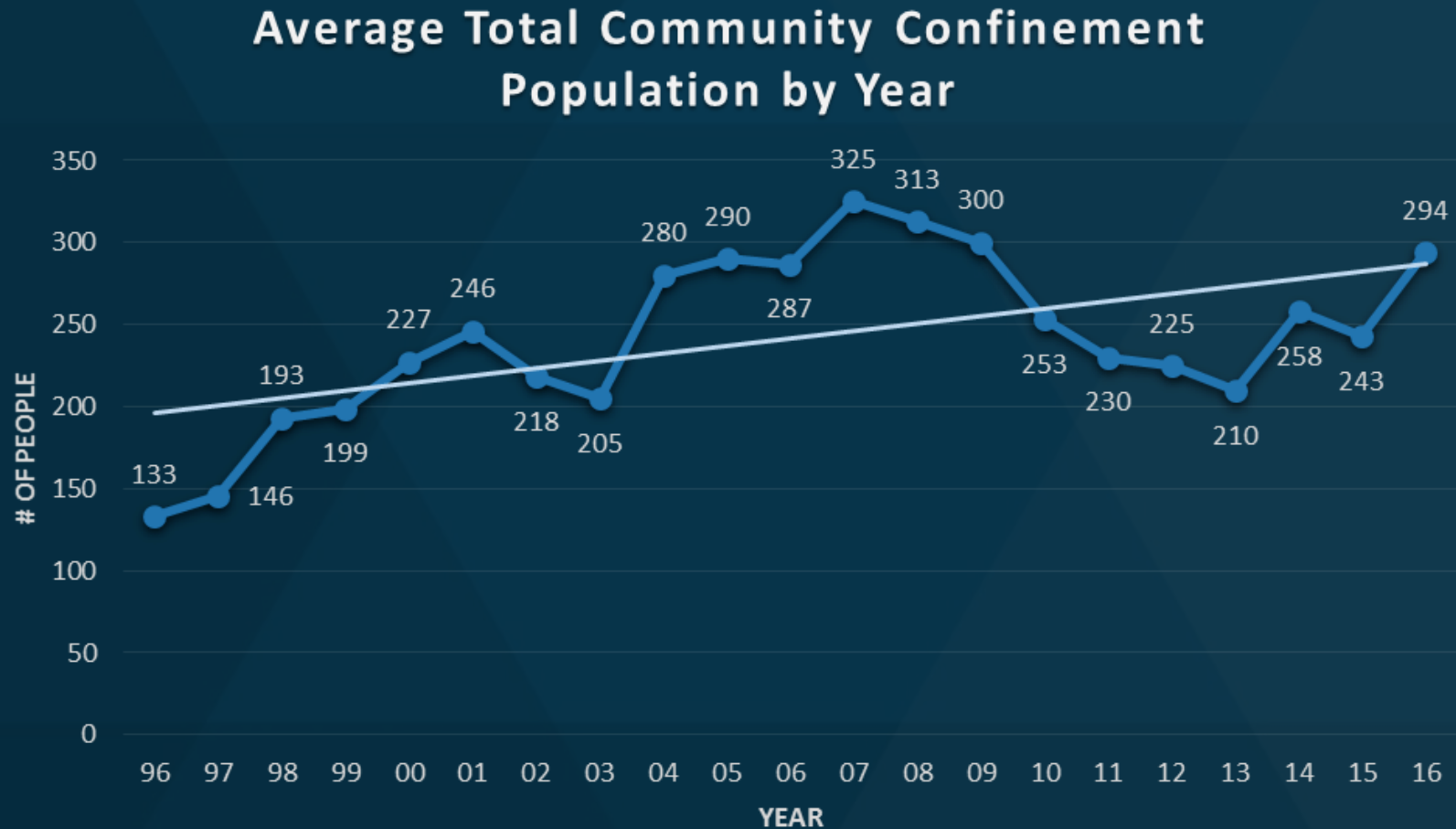
HOW DOES THE RI COMMUNITY SUPERVISION POPULATION COMPARE?

There has been a 121% increase over the past twenty years in this population.



RI INMATES SERVING LIFE OR LIFE WITHOUT PAROLE

- As of December 31, 2016 there were 31 Rhode Island inmates serving a sentence of Life without Parole (4 were serving out-of-state).
- As of December 31, 2016 there were 206 Rhode Island inmates serving a Life Sentence* (22 were serving out-of-state and 1 was a Dual Lifer).

* this total **excludes** 16 Out of State Lifers (OOS Lifer) serving another state's sentence in RI according to interstate compact and **includes** Dual Lifers which are inmates serving multiple states' sentences
